#### DEBBIE DILLON

Debbie Dillon is in her second year as President of the Southern California Chapter of ASPA and the Deputy Executive Director of Administration for the Southern California Association of Government's (SCAG) where she is responsible for leading and managing the Financial, Human Resources, and Information Technology functions. She possesses over 26 years of public administration experience with 13 in executive management. She has worked for higher education institutions and water districts throughout the state as well as her responsibilities at SCAG where she has been since 2002. She holds a degree in Political Science with a concentration in Public Administration from CSU, Fullerton.

#### DEAN MISCZYNSKI

Dean Misczynski is currently an adjunct fellow at the Public Policy Institute of California, where he specializes in local government financing, water financing, and budget realignment. He was the founding director of the California Research Bureau in the California State Library. The Bureau, which began in 1991, provides policy research services to both houses of the California Legislature and the Governor's Office. Dean also worked for California's Senate for several years, where he drafted the Mello-Roos Act, the Infrastructure Financing District law, and other local financing legislation. He published "The Fiscalization of Land Use" in 1986, the root of that odd phrase. He was deputy director of Governor Jerry Brown's Office of Planning and Research, where he was an author of Brown's Urban Strategy for California. He coauthored *Windfalls for Wipeouts* (about property "takings" and how to pay for them) while a research economist at UCLA's Law School. His graduate and undergraduate education was at Stanford in economics.

## Deputy Chief LAURA FARINELLA

Deputy Chief Farinella was hired by the Long Beach Police Department in 1990. Since starting her career she has worked all Patrol Divisions, was a Field Training Officer, Academy Instructor, Administrative Corporal, Internal Affairs Sergeant, and assistant to the Deputy Chief of Investigations. As a commander she has managed the Communications Division, East Patrol Division and the Gang and Violent Crimes Division, and was Chief of Staff to Chief Jim McDonnell. Deputy Chief Farinella holds a Bachelor Degree in Communications from Chapman University, and a Master of Science Degree in Emergency Services Administration from the California State University of Long Beach. She is currently heads the Chief's Gay and Lesbian Advisory Committee, and is on the Department's Leadership Committee, which promotes women in leadership roles, and Executive Director of the Long Beach Police Historical Society.

## DANIEL R. JORDAN, Ph.D., CGFM

Dr. Daniel Jordan is Director of Finance for the City of La Cañada Flintridge, California, where he oversees all of the City's financial operations. Previously, Dr. Jordan was Budget Officer for the City of Simi Valley, California, where his responsibilities included the development and oversight of the City's \$150 million Annual Budget and Five-Year Capital Improvement Program (CIP). Prior to joining Simi Valley, Dr. Jordan worked as a consultant to public sector agencies for eight years, providing local and state governments nationwide with multiyear financial and budget projections, fiscal and economic impact analyses, project financing strategies, and a range of other analytical studies and policy assessments. He is also Adjunct Associate Professor at the University of Southern California's Sol Price School of Public Policy, where he currently teaches in the Masters Program of Public Administration.
